Davis spoke on the WLD 9<sup>th</sup> District Life Membership. An audit was done and it came back clean. Bro Davis is on the board of directors for the OPPFFCU. Please consider doing business with our credit union. Bro. S. Holley State Advisor for the State of Texas asked brothers to be diligent and keep an eye on the brothers.

<u>Achievement Week</u>: Bro. Richards gave a report for Bro. R. Johnson. The week of events was held and ended with the fellowship at the fraternity house. He gave the number of brothers who showed up at each event. From a budget standpoint they are looking at about \$4000 in profits.
